Level UP

CFI's Level Up program provides paid training and career support to individuals facing self-identified employment barriers and lacking access to conventional funding sources.

CFI Opens 3rd Commercial Kitchen at Concordia 27

Through our Employment and Nutrition Services, we strive to improve neighborhood health by offering nutritious meals and job training. This important work is a win/win because it empowers community members to overcome employment barriers (e.g., homelessness, criminal backgrounds and disabilities) to contribute to a healthier Milwaukee.

In 2024, we opened our third commercial kitchen, thanks to a partnership to develop vacant property on 27th Street in Milwaukee's Concordia neighborhood into a mixed-use space, called Concordia 27. The new space features a community center, affordable housing and commercial kitchen serving as a catalyst for health, social and economic improvements for City of Milwaukee and Southeast Wisconsin residents.

By the end of 2024, CFI's Employment and Nutrition Services team prepared and delivered a record 4.85 million meals to 125 locations! We're grateful to our community partners who helped make Concordia 27 a reality, supporting healthy, vibrant communities through nutritious food and meaningful employment.

Farm 2 Table Program

Achieves 2nd Successful Year

One of LIFE Services' most popular activities is the Farm 2 Table program, which completed its 2nd successful year in 2024. This innovative farming concept provides learning opportunities and work skills training for people with intellectual and developmental disabilities. Fresh, healthy produce is grown in two hoop houses and an outdoor garden for local restaurants and sold at a monthly farmers market, located at Sixth Street and Norwich Avenue, along the Garden District neighborhood's Green Corridor. Some of the produce is donated to local food pantries. Nearly 70 participants help with weeding, watering, planting, harvesting and delivering produce in our Farm 2 Table program.

CFI's LIFE Services program provides various experiences and opportunities to help people with intellectual and developmental disabilities enhance their independent living skills, improve their health and well-being, prepare for employment—if that's their goal—and engage actively in their communities. Programming includes pet, art, horticulture and music therapy, fitness classes, sensory experiences, nutrition and cooking opportunities, community integrated outings, multicultural and seasonal activities, and more.

Diners at Milwaukee's Braise restaurant enjoy fresh romaine leaves, bronze fennel and other produce from CFI's Farm 2 Table urban garden. In exchange for a monetary donation, restaurants such as Braise receive CFI's freshly grown goods.

This partnership is crucial for providing individuals with physical or developmental disabilities or limiting neurological conditions the opportunity to work in the garden.

As individuals cultivate rows of vegetation, they also develop life skills that help them live independently by overcoming their fears, boosting their self-confidence and understanding what independence can mean. To ensure that people of all abilities can experience the garden, it is accessible and accommodating, featuring physical modifications for various levels of mobility and socialization.





Making Milwaukee a Model City

CFI's broad range of services that provide advocacy and support, giving our team a unique perspective into the intersection of disability and mental health. Disability experiences, such as social isolation and discrimination, can increase the likelihood of mental health conditions. Conversely, mental health conditions can exacerbate existing disabilities, creating a complex interplay of factors that affect well-being.

Through our own comprehensive services and in collaboration with strategic partners, we dramatically increase access to care, expand the state's capacity to address the overdose crisis, reduce mental health-related hospitalizations, help address the workforce shortage and create innovative partnerships with law enforcement, schools and hospitals to improve care.

As a SAMSHA Certified Community Based Health Clinic (CCBHC), CFI can connect with those who are the most vulnerable and in need of crucial behavioral health and crisis services. As funding for behavioral health services remains in flux, we remain committed to providing access to a comprehensive range of mental health services, regardless of their diagnosis.

CFI's \$4 million SAMHSA CCBHC grant funds critical behavioral health services in Milwaukee County. The funding supports treatment for residents of all ages living with serious mental illness, substance use disorders, co-occurring conditions and youth with serious emotional disturbance.*

For the 24th consecutive year, we have been accredited by the Commission on Accreditation of Rehabilitation Facilities (CARF).

This 3-year accreditation represents our adherence to the highest quality and care standards in providing rehabilitative programs and services. Additionally, CARF's surveyors offered no recommendations for improvement, which is achieved by only 3 percent of CARF surveys—ranking CFI among the best in its class.

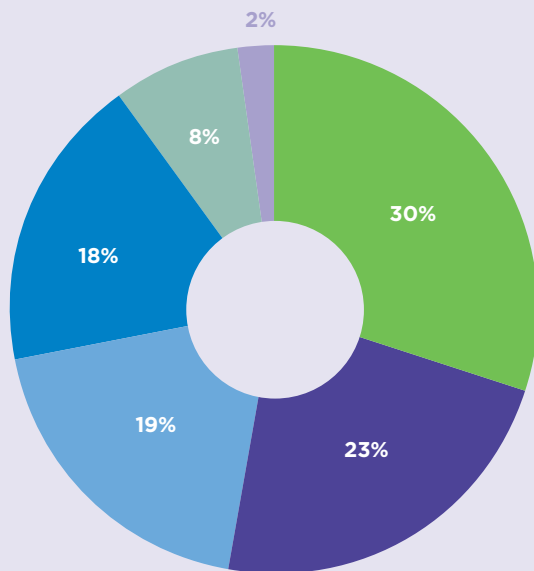

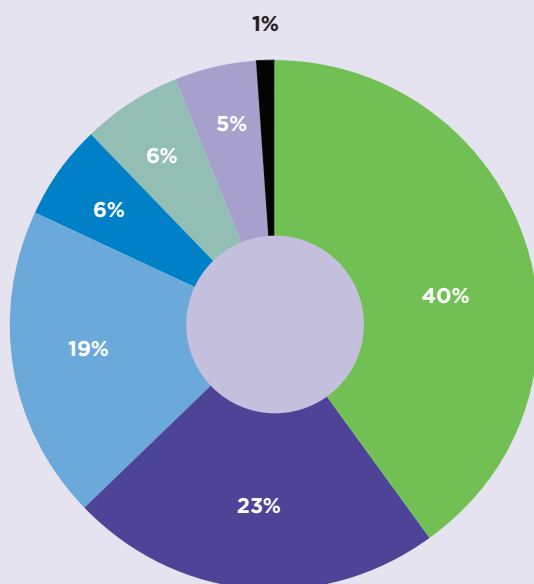

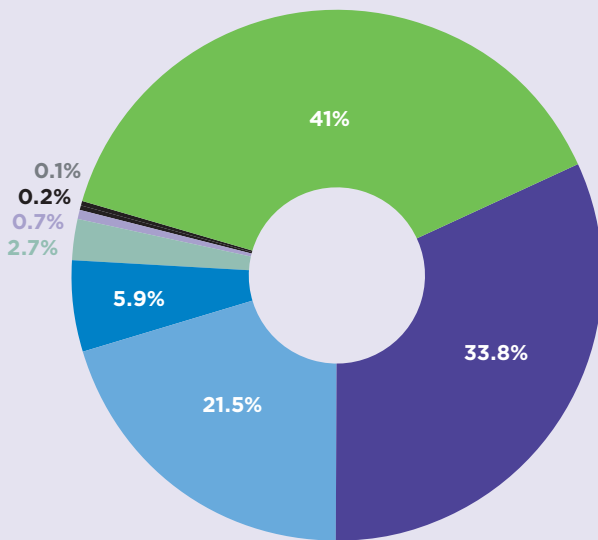

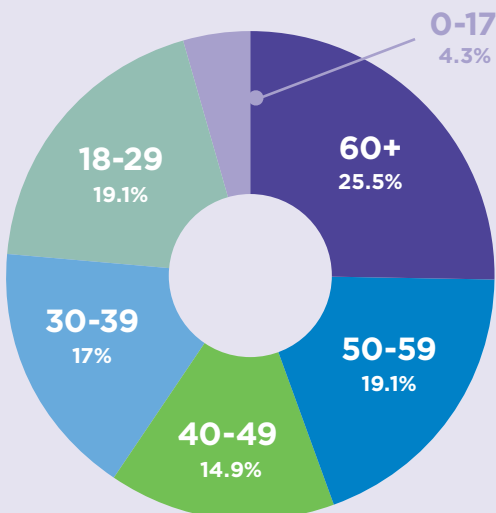

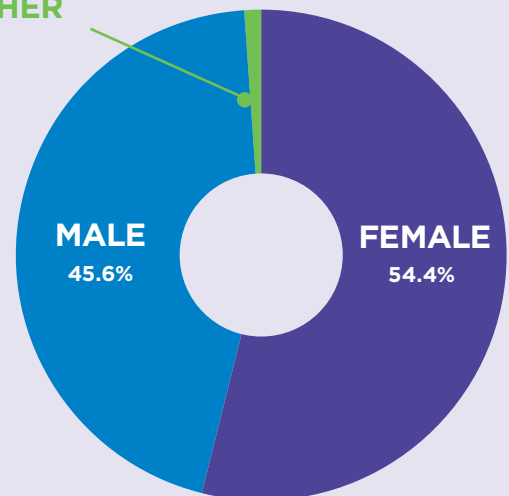
